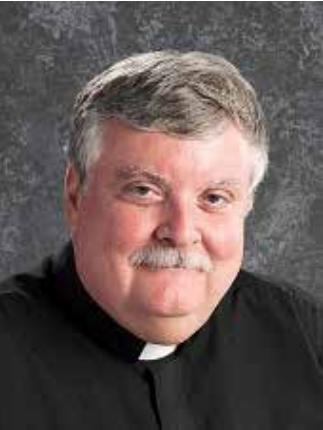

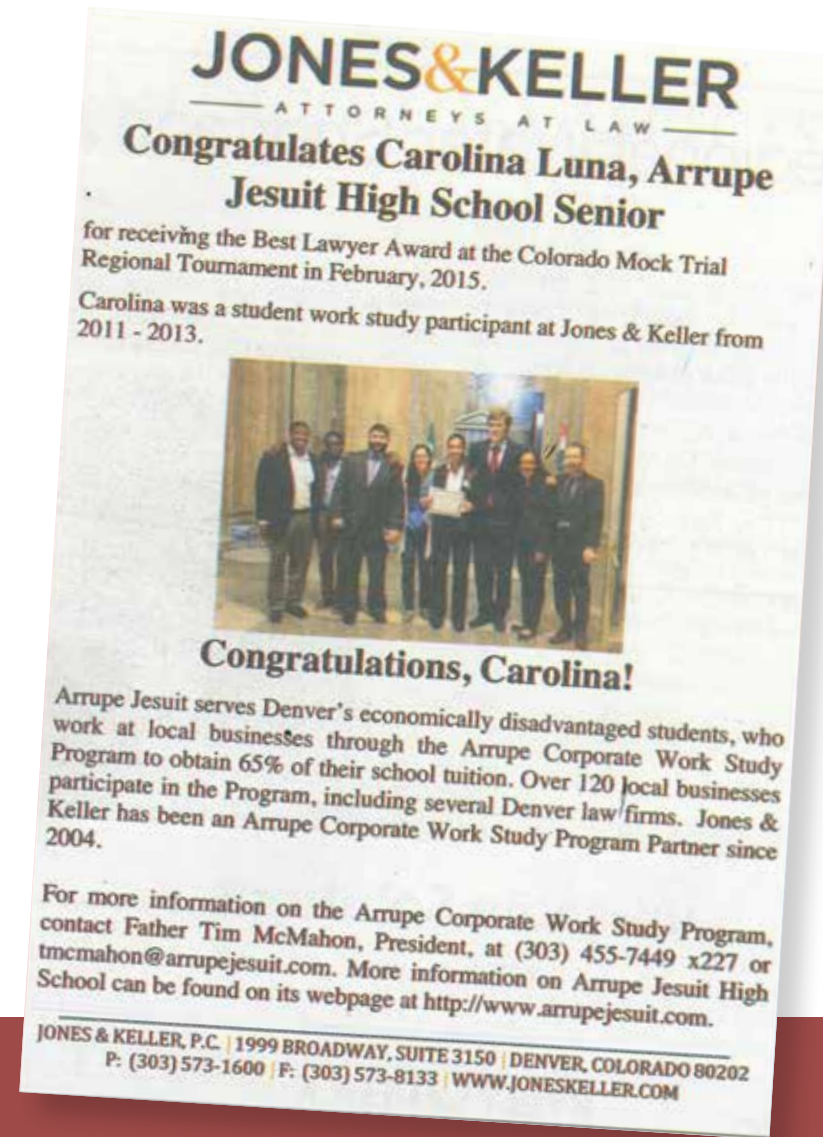
CWSP PARTNER SPOTLIGHT

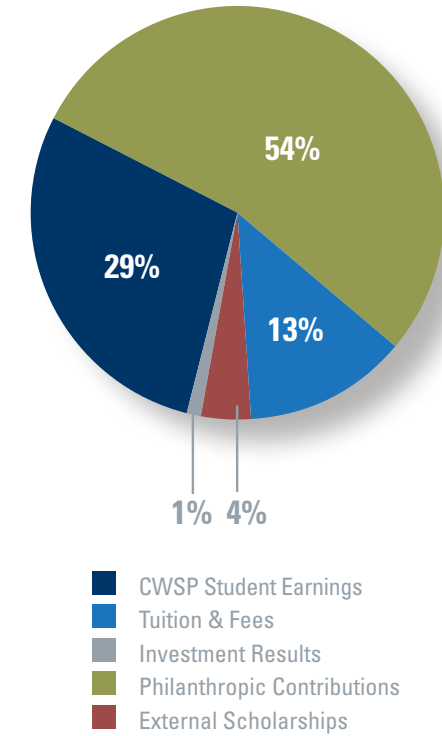

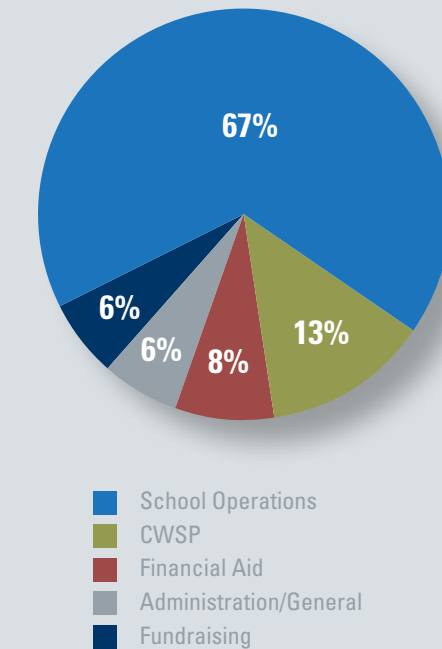

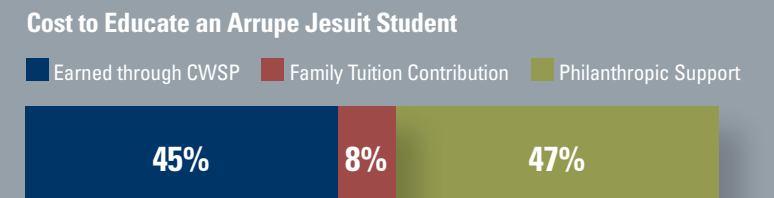
