LETTER FROM THE PRESIDENT



There are certain numbers that are so striking and deserving of celebration that sometimes we fail to pause and consider the story that informs those numbers.

This proves to be true with the statistics from our most recently graduated class, the Class of 2021. Of the 98 Seniors who graduated in May, 70 are first generation high school graduates and 94 are first generation college bound. That remarkable group of young people left Arrupe Jesuit to attend 22 different colleges and universities across the country, earning over \$17.2 million in merit and community based scholarships. You'll remember, of course, the 10 Daniels Scholars from that class.

In a normal school year, these accomplishments demand our attention. That this class achieved such incredible success in the midst of a global pandemic requires us to reflect on the efforts of those who helped position them for greatness. Against a backdrop of early morning temperature screens, ever changing instructional models, and an unprecedented catalogue of student need, Principal Fr. Nugent, the administration, and our faculty and staff responded in a manner that is most definitely Ignatian. In addition to developing and implementing a unique academic structure, the Arrupe community delivered the support systems and formational experiences that define the school in ways previously unimagined.

Study halls and club meetings were moved to small group settings on Friday mornings, counseling sessions were held on secure virtual platforms, and retreats were moved on campus, including Kairos – where, for 12 days and nights, the classrooms of Arrupe were transformed to the sacred space of a Jesuit retreat house.

Nothing, however, speaks of Arrupe Jesuit's commitment to "cura personalis" more than the 800 phone calls made by faculty and staff members to the families of students who were struggling to stay engaged during an upside down school year. Some days, these were easy calls asking students how they were doing, was everyone at home doing well, was there anything they needed. On other days, the calls were directly reminding students that they needed to be present in class, that assignments needed to be submitted, and that there were consequences for the choices they made.

These efforts were focused on a single goal: to remind students that Arrupe remained committed to its promise of a hope-filled future and that the adults of Arrupe would continue to accompany them on that journey despite the challenges of the day.

In a series of letters written during the pandemic and published under the title Let Us Dream, Pope Francis writes that community is "... the sense of belonging to one another and to the whole of humanity, is the capacity to come together and work together against a shared horizon of possibility."

I believe last year's Seniors were inspired by the promise of Pope Francis' shared horizon. On Utica Street they lived those possibilities that his Holiness describes. As I reflect on the accomplishments of last year, I thank those at Arrupe Jesuit who served the school each day bringing those possibilities to life for all our students. I also thank you, our friends, who share in our blessed mission and are equally responsible for making real the possibilities of tomorrow for our students.

Mark Anderson is the Maintenance Director at Arrupe Jesuit. He is an essential contributor on our team who keeps our building and facility maintenance running smoothly, ensures the building and grounds are clean and beautiful, and he is on-call for any emergencies that come with a 50+ year old building. Mark kept our community safe during the Pandemic, which included upgrades to the air filtration system, increased cleaning and sanitization protocols, and was there every day to assist with morning health screenings and student cohort supervision. Mark's love for Arrupe students is palpable. He talks with them in the halls, employs students through CWSP, serves as a group leader on Kairos retreats, and leads a faith formation student group.

"I first came to know Arrupe in 2014. I was the Electrical Superintendent for the construction of the school's South addition, which transformed the old parking lot into a new cafeteria, outdoor patio, and seven beautiful new classrooms. I had a 26 year career as an electrician and in April of 2015 was offered a position here at Arrupe as the Facilities Manager. I was scared to death of working with teenagers and had no idea what to expect. I spent my first two years at Arrupe focusing mostly on developing the facilities maintenance programs, and getting to know the community. All along feeling pulled to get more involved in the students' lives, as they are really at the center of Arrupe's mission. During these two years I had also finished schooling and an internship for my pastoral credentials for the Assemblies of God Church. I was serving as a community life pastor at our local church, but I felt like something was still missing. In 2019 I was able to attend my first Kairos retreat, and my mind was blown away. I could not believe how authentic and vulnerable our students were on this retreat. I started many relationships with those students that still continue to this day. I finally found my heartbeat in the school, and how to become part of the student life here. I have since then attended a total of 3 Kairos retreats, and started a student spiritual formation group called LT4 (Live the 4th). LT4 is a group that is available to all students who have attended Kairos, and our purpose is to continue the personal growth and faith formation that begins at Kairos. We talk about all sorts of things, including how to love people and God extravagantly, growing in our faith, and sharing our story to help someone else grow in their faith. We, as a group, try to discover how we can continue to live our best lives for God, our community, and the rest of the world.

This is where my heart is, this is where I find my true joy. It's being with the kids and growing our lives together. What I have discovered through our students is this: The most powerful force on this earth is a person who is brave enough to simply be themselves. A person who is brave enough to be who God created them to be. This is my favorite thing to tell kids, and I probably say it 4-5 times a week. Just be brave, just be You, because You are awesome!

I like to say that the work I do to maintain the building has just become my excuse to come to Arrupe every day and be a part of our students' lives. I am honored to work here and my life is truly enriched by this community and our amazing students."






Arrupe Jesuit High School had the benefit of a 6-month operating reserve to lean on during the financial difficulties due to the pandemic. With Corporate Work Study revenue down about \$2MM, increased philanthropic efforts allowed our doors to stay open. Additionally, AJHS was grateful to receive a \$1 million planned gift pledge to be paid out in future years, reflected in Philanthropic Contributions in FY21. 
