# Arrupe Jesuit High School Corporate Work Study Program

To best accommodate your family's needs, two morning check-in/travel options and three afternoon return-from-work/travel options are available. Please check one morning option and one afternoon option listed below. For all options, Arrupe Jesuit will purchase RTD Light Rail passes for students.

### **Morning Check-In Options**

For both of these options, upon arriving at their designated Light Rail Station, students will either ride an Arrupe Jesuit bus or ride an RTD shuttle bus to his or her worksite in the Denver Technical Center.

- ☐ Your student arrives at Arrupe Jesuit at 7:00 AM. He or she must check in with CWSP Staff and then ride an Arrupe Jesuit bus to the Union Station Light Rail Station (located at 17<sup>th</sup> Street and Chestnut Place) to board an RTD Light Rail train at 7:43 AM.
- ☐ Your student arrives at the Union Station Light Rail Station (located at 17th Street and Chestnut Place) no later than 7:20 AM. Families can drop-off students or this may be a useful option for students who use RTD buses to travel to/from school. All downtown bus transfers occur in the new underground Union Station complex, adjacent to the Light Rail Station. Students must check in with a CWSP representative and board the RTD Light Rail train by 7:43 AM.
- □ A family member transports student directly to his/her worksite no later than the arrival time CWSP has specified.

#### **Afternoon Return-From-Work Options**

For the first two options, students will either ride an Arrupe Jesuit bus or ride an RTD shuttle bus from his or her worksite in the Denver Technical Center to a designated RTD Light Rail Station.

- ☐ Your student rides the RTD Light Rail to Union station, arriving between 5:10-5:20 PM. An Arrupe Jesuit bus will transport students to school, arriving no later than 5:50-6:00 PM.
- ☐ Your student rides the RTD Light Rail train to the Light Rail Station that best meets your family's needs. Students may travel home independently, either by pick-up by a family member or by riding an RTD bus.
- ☐ Your student is picked-up at his or her worksite by a family member at the designated work departure time.

## **CWSP TRANSPORTATION WAIVER AND RELEASE OF LIABILITY**

In consideration of Arrupe Jesuit and the CWSP arranging for transportation services for the student by way of the RTD Light Rail and/or RTD shuttle bus or Arrupe Jesuit bus in conjunction with his or her involvement in CWSP-related activities, I, on behalf of myself and the student, authorize Arrupe Jesuit and the CWSP to arrange for the RTD to provide transportation services for my child to and/or from his or her CWSP-related activities by way of purchase of RTD Light Rail passes.

I understand that the RTD is not in any way owned by, affiliated with or under the control of Arrupe Jesuit or the CWSP and I am releasing, discharging and waiving any claims or actions that I may have presently or in the future against Arrupe Jesuit and the CWSP for the acts or omissions of the owners, agents, officers, representatives, volunteers or employees of the RTD and/or any other third-party individual or entity. Accordingly, I hereby voluntarily release, waive, discharge, hold harmless, defend and indemnify the owners, agents, officers, representative, volunteers or employees of Arrupe Jesuit and the CWSP from and against any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise as a result of the student independently travelling to and/or from CWSP-related activities by way of the RTD Light Rail and/or RTD shuttle bus and/or Arrupe Jesuit bus.
